Independent Living

Self-advocacy and independent living skills are critical progressions to the development of the brain. As a nineteen-year-old, I was diagnosed with inattentive ADD. During the time of my diagnoses, I was faced with the challenge of having to re-apply for Medicaid and I was assisted through the process of applying to receive care. The time in between applying for health insurance was met with challenges as I had to delay my appointment times to receive care, but after receiving coverage I was able to address those needs. As a young girl I did not know how to articulate my silent experience, but my learned efforts of self-advocacy have allowed myself to grow. An influential partnership with Tessa has allowed me to focus on establishing a stable future for myself. Together we began to work on schedule planning, budgeting time, and job readiness in creating an understanding of how to utilize my resources and time while in school. The continuous support from Valley Associates for Independent Living has allowed me to develop the practice of working on setting achievable goals through reminders and planning of my time. My testimony has also enlightened how I have been able to receive support through the connections of places that accommodate my experience. I remember the day that I walked into the office of the Department of Aging and Rehabilitation Services (DARS). I was met with so much patience and understanding of my experience. The staff allowed me to explain my experience and offered me resources that would help continue to guide me while in college. I'm a first-generation college student and my first year of college was challenging and I had to learn the importance of utilizing the resources around me. After a year of setting up partnerships and working towards independent living, I have felt supported, understood, and seen in my experience. I am thankful for the partnerships that I have been able to develop with both advocacy offices and I hope that I can continue to strengthen my partnerships with these services. The support and partnership of VAIL and DARS has allowed me to see growth in my experience.

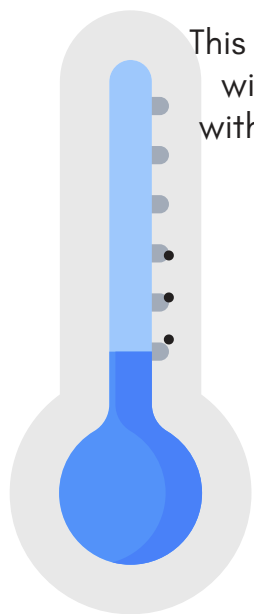

EnergyShare

Valley Associates for Independent Living, Inc. (VAIL) has an EnergyShare program in collaboration with Dominion Energy. This program provides for a \$500 credit to be applied to your energy bill (gas, electric, or propane) for individuals who meet the criteria. If you are interested in applying, please contact the VAIL staff person that you work with regularly or Andrea King at andrea@govail.org. You must reside in Harrisonburg, Lexington, Buena Vista, Waynesboro or Staunton City or the counties of Rockingham, Augusta, or Rockbridge.

- Must include a recent bill from your energy provider and complete an application
- Must not have received energy share assistance in the past 12 months
- Must have an open goal with VAIL that you are working on with VAIL staff
- Cannot have your payment set up for automatic payments
- Cannot reside in subsidized housing or receive a housing voucher

This is a first come, first serve program. We make no guarantee that payment will be made until after the whole process is complete. It is imperative that you continue making payments on your account. Please reach out with questions.



Virginia Housing Modification Programs

OWNER-OCCUPIED MODIFICATION VIRGINIA

Virginia Housing's Owner-Occupied Modification Grant makes funding available to assist with modifications to homes to make them accessible to elderly individuals or owners with disabilities. The modification must directly address barriers created by the disability. These funds are available to persons earning 80% or less of the area median income, based on HUD guidelines. These income limits are available here:

This program is targeted at homeowners aged 65 and older. Applicants under 65 must provide written documentation of the need for the accessibility improvement, such as a doctor's letter, insurance documentation, or social security documentation showing the nature of the disability. Applicants must provide documentation of their ownership of the property.

Granting Freedom is a grant program for home modifications for disabled veterans and service members who sustained a line-of-duty injury resulting in a service-connected disability.

Funds of up to \$8,000 can be used to make a home wheelchair accessible, to install grab bars in a bathroom, or to make other modifications that help eligible recipients become independent. Funding to pay for modifications to houses and apartments is available on a first come-first served basis.



RENTAL UNIT ACCESSIBILITY MODIFICATION GRANT

Landlords are required by fair housing laws to allow modifications to an apartment or rental house to make it barrier-free to the tenant. However, tenants usually bear the cost of these modifications, which can be substantial. Fortunately, help is available through grants offered by Virginia Housing.

Individuals with a disability who rent a home and who earn 80% or less of the area median income may be eligible for grant assistance up to \$8,000.

Applications for all of these programs must be submitted by a Virginia Housing-accepted agent. VAIL is a registered agent in Planning District 6.
